ANNUAL ACTIVITY REPORT 1991 - 1992

SECRETARY'S REPORT

In the previous Annual Activity Reports, the Environmental Impact Screening Committee (EISC) has included a section entitled "Chairman's Report". In this Annual Activity Report, however, there is no Chairman's report because the EISC has been without a Chairman since August 1991. For this reason, the Secretary wrote this report.

In August 1991, Mr. Ewan Cotterill, who was Chairman since the EISC commenced its operations in 1986, resigned. According to the protocol established under the *Inuvialuit Final Agreement* (IFA), the EISC Chairman is appointed by the Government of Canada with the consent of the Inuvialuit Game Council (IGC). In September 1991, the IGC initiated the appointment of a new Chairman by submitting a candidate's name to the Department of Indian Affairs and Northern Development (DIAND).

From September to December 1991, the DIAND embarked on a search for other individuals for the Chairman position whose qualifications included northern residency. The reason given was that DIAND preferred to appoint someone residing in either the Yukon or the Northwest Territories over someone, as the IGC's candidate, residing in southern Canada. Northern residency is not an official requirement of the IFA.

After this search produced no results, DIAND agreed in December 1991 to the IGC's original candidate. In a response, the IGC wrote that "we trust that you will expedite these appointments\(^1\).... This is critically important with respect to the EISC which, as you are aware, has been forced to operate at less that full compliment since Ewan Cotterill's departure".

Six months have now lapsed since the IGC's response. When this lapsed time is combined with the earlier time spent on the search, the EISC has been without a Chairman for nearly one year. At the time this report was written, the Order in Council, the final step to appoint the new Chairman, remains outstanding.

For the EISC to function without a Chairman, one Member is elected acting Chairman at each meeting. While the EISC has managed in this impeded state to conduct most routine operations, it is the Members' opinion that the completion of pivotal documents, such as the *Operating Guidelines and Procedures*, require the full involvement of a Chairman. For this reason, the revised *Operating Guidelines and Procedures*, for example, originally scheduled for publication in 1991, remains unfinished.

During this fiscal period, the EISC worked on clarifying several outstanding matters pertaining to the Environmental Impact Screening and Review Process. These matters include the IGC blanket referral letter of April 1987, and the screening of developments on Inuvialuit Private (7(1)(a) and 7(1)(b)) lands. As well, the EISC continued to screen proposed development activities: 27 submissions were screened in 1991-1992, a decline from 30 submissions screened in the previous year.

The other appointment was for a new Chairman for the Environmental Impact Review Board.

In the upcoming year, the EISC's membership will undergo change. In addition to the appointment of a new Chairman, both the Government of Canada and the Yukon Territorial Government have appointed new Members. With this new membership, the EISC will need some time to readjust before it begins to tackle some of the outstanding issues and business matters set aside for so long.

PERIOD OF THIS REPORT

This report describes the affairs of the Environmental Impact Screening Committee (EISC) for the fiscal period of April 1, 1991 to March 31, 1992.

This <u>Annual Activity Report</u> is the fourth annual activity report of the EISC.

GOALS OF THE INUVIALUIT FINAL AGREEMENT

The EISC operates within the scope of the *Inuvialuit Final Agreement* (IFA) to achieve the basic goals expressed in Section 1 of the IFA:

- To preserve the Inuvialuit cultural identity and values within a changing northern society
- To enable the Inuvialuit to be equal and meaningful participants in the northern and national economy and society
- To protect and preserve arctic wildlife, environment and biological productivity

AUTHORITY OF THE ENVIRONMENTAL IMPACT SCREENING COMMITTEE (EISC)

The EISC was established under the terms of the IFA between Canada and the Committee for Original Peoples Entitlement. The IFA became law under the <u>Western Arctic (Inuvialuit) Claims</u> Settlement Act [S.C. 32-33 Elizabeth II, C.24.] on June 28, 1984.

The <u>Western Arctic (Inuvialuit) Claims Settlement Act</u> takes precedence over all other legislation in case of conflict. Developers and operators are compelled by this Act to comply with the provisions of the Environmental Impact Screening and Review Process.

The IFA requires the screening of developments and activities of consequence to the Inuvialuit Settlement Region that could have a significant negative impact on the environment, or significant negative impact on present or future wildlife harvesting.

The IFA provided for the establishment of an EISC to carry out the screening of these developments. Provisions governing the operation of the EISC are described within the IFA, and also within the by-laws of the EISC. Subject to those provisions, the EISC's *Operating Guidelines and Procedures* govern its activities with regard to the actual screening of development proposals and other activities.

Three members are appointed by the Inuvialuit Game Council, one member is appointed by the Government of Canada, one member is appointed by the Yukon Government, and one member is appointed by the Government of the Northwest Territories. The Chairman is appointed by Government of Canada with the consent of the Inuvialuit Game Council. The Secretary is appointed by resolution and is the only full-time official of the EISC.
