




Figure 1. Private Inuvialuit Lands, Crown Lands and National Parks within the Inuvialuit Settlement Region.

Message from the Chair

To begin this year's report, I would like to acknowledge the years of service of two members of the Environmental Impact Screening Committee (EISC). Mr. Morris George was appointed as a member of the EISC in November 2006 and his term expired in November 2009. Mr. Darren Nasogaluak was first appointed to the EISC in March 2004 and his term ended in October 2009. We will miss the wisdom, knowledge of the land and sense of humour that they brought to our discussions.

The EISC continues to carry out the mandate provided to it in the Inuvialuit Final Agreement (IFA). The reporting period of this annual report, April 1, 2009 to March 31, 2010 was a relatively busy one with a variety of project submissions. As per the amendments to the IFA, the EISC continues to provide recommendations to the licensing bodies for terms and conditions under which a development may proceed, with a view to limiting the potential negative impacts of such developments on the natural environment and Inuvialuit traditional harvesting activities.

During this reporting period the Committee continued their efforts towards completing revisions to the Operating Guidelines and Procedures. A draft document was completed at the end of March and is waiting for review by legal counsel. The Committee expects to finalize the document during the summer of 2010.

The appointment of the EISC's Chair, Mr. Fred McFarland, expired on March 20, 2010. At the time of this report the Committee remains without a Chair.

On behalf of the Committee, I would like to extend our thanks to Fred, Darren and Morris for their positive contribution to the EISC's work and wish them all well. I would also like to thank the staff of the Joint Secretariat for their on-going support and, particularly, that of the EISC's Environmental Assessment Coordinator, Barb Chalmers.

Period of this Report

The Environmental Impact Screening Committee (EISC) has produced twenty three annual activity reports since its inception in 1986. This report describes the EISC's activities for the fiscal period of 1 April 2009 to 31 March 2010 – its twenty fourth year of operation.

The Inuvialuit Final Agreement

On June 5, 1984, the Committee for Original Peoples' Entitlement (representing the Inuvialuit) and the Federal Government of Canada signed the Inuvialuit Final Agreement (IFA), which was subsequently legislated under the Western Arctic (Inuvialuit) Claims Settlement Act [S.C. 32-33 Elizabeth II C.24.]. Provisions of the IFA enable the Inuvialuit to participate and be meaningful partners in all decisions-making processes dealing with the management of the environment and wildlife within the Inuvialuit Settlement Region (ISR). Section 1 of the IFA expresses the following principles.

- To preserve the Inuvialuit cultural identity and values within a changing northern society
- To enable the Inuvialuit to be equal and meaningful participants in the northern and national economy and society
- To protect and preserve arctic wildlife, environment and biological productivity

As one of five co-management groups established under the terms of the IFA, the EISC plays a vital role in achieving these stated goals through implementing the screening portion of the IFA Environmental Impact Screening and Review Process.

Mandate of the Environmental Impact Screening Committee

The Western Arctic (Inuvialuit) Claims Settlement Act and the IFA take precedence over any other federal, territorial, provincial, or municipal law to the extent of any inconsistency or conflict between them. Developers, operators, and regulatory agencies are compelled by this act to comply with the provisions of the IFA Environmental Impact Screening and Review Process.

The IFA requires the screening of developments and activities of consequence to the ISR that could have a significant negative impact on the environment or wildlife harvesting. The IFA also dictates that regulatory agencies must not issue licenses or approvals that permit any development to proceed without environmental screening and, if necessary, review.

Section 11 of the IFA provided for the establishment of the EISC to carry out the screening of relevant developments. Provisions governing the activities and operation of the EISC are described mainly within Section 11 and 13. Section 11.(17) requires the EISC to make one of the following decisions after examining a project description.

- a) that the development will have no significant negative impact and may proceed without environmental impact assessment and review;
- b) that the development, if authorized subject to terms and conditions recommended by the Screening Committee, will have no such significant negative impact and may proceed without environmental impact assessment and review;
- c) that the development could have significant negative impact and is subject to assessment and review, or
- d) that the development proposal has deficiencies of a nature that warrant termination of its consideration and submission of another project description.

Subject to the aforementioned provisions, the EISC produced its Operating Guidelines and Procedures, which governs its routine activities in regard to the actual screening of development proposals.

Membership

The EISC consists of seven members, including the Chair. The Inuvialuit Game Council (IGC) appoints three members. The Government of Canada (Canada), the Yukon Territorial Government (YTG), and the Government of the Northwest Territories (GNWT) nominate one member each, who are then appointed by the Government of Canada. The Government of Canada with the consent of the IGC appoints the Chair. Each member is appointed for a three-year term with the option of re-appointment if agreed to by the nominating and appointing bodies.

Even though particular groups appoint the members, the EISC serves as a non-partisan organization. The members are expected to contribute as experienced individuals and not as representatives of their appointing body.

Morris George's term expired on November 6, 2009 and John Ryder was appointed. Darren Nasogaluak's appointment ended in October 2009. Eric Cockney was reappointed in October 2009. Fred McFarland's appointment as Chair expired on March 20, 2010. As of March 31, 2010 the EISC was without a Chair.

Administrative and Technical Assistance

The EISC receives administrative, technical, and clerical support from the Joint Secretariat – Inuvialuit Settlement Region situated in Inuvik, NT. The EISC Environmental Assessment Coordinator who serves as the Secretary to the EISC provides full-time assistance. Barb Chalmers has been working in this position since June 2007.

During the period of this report the EISC also received administrative support from various employees of the Joint Secretariat including: Dr. Norm Snow, Executive Director; Peggy Madore, Senior Administrative Officer; Connie Gordon and Patricia Campbell, Office Managers; Erica Lugt, Finance Officer; Meeka Kisoun and Philippa Vos, Travel/Accommodation Coordinators; Bernice Joe, Secretary/Receptionist; Myrna Button, Office Clerks/Librarians; and Eli Arkin and Eli Nasogaluak, EIRB Coordinators.

John Donihee, John Donihee Professional Corporation provided contractual legal services.

Activities

Members attended screening meetings approximately every five weeks and participated in other activities on behalf of the EISC, as required, to fulfill the mandate of the EISC.

Regular meetings

The EISC held 9 regular meetings in Inuvik, NT on the following dates: April 29- May 1, 2009, June 10-12, 2009, July 17, 2009 (Conference Call), August 19-21, 2009, October 7-9, 2009, November 3&4, 2009, December 16-18, 2009, January 20-22, 2010, March 10-12, 2010.

In addition to the regular EISC meetings the following meetings were held to work on the revisions to the Operating Guidelines and Procedures:

- December 9 & 10, 2009 Johnny Lennie, Fred McFarland and Barb Chalmers attended the office of AECOM in Calgary to review the Operating Guidelines and Procedures with legal counsel, John Donihee.
- The Committee held a special Conference Call on March 19, 2010 to review draft versions of the Operating Guidelines and Procedures.

Submissions

It is the responsibility of the proponent to submit a project description to the EISC for environmental screening. Screening decisions are made by a panel of five EISC members. The Panel consists of the Chair, two Inuvialuit members, the Canada member, and the Territorial member nominated by the territory (YT or NT) within which the project is to occur. Decisions are made on a majority vote basis, with the Chair voting in the case of a tie.

In regards to submissions received by the EISC, 2009/2010 was a relatively quiet year when compared with the previous year. 34 descriptions were submitted.

Of the total submissions, no project descriptions were withdrawn by the proponent prior to the completion of the screening process.

No projects were referred to the Environmental Impact Review Board.

In summary, the EISC screened 33 project descriptions during 2009/2010 including: Hydrocarbon exploration projects (2); Research projects (19); Tourism projects (4); Seismic projects (2); Clean Up projects (3); Infra-Structure projects (3).

During 2009/2010 the EISC decided that:

Nineteen of the proposed developments would have no significant negative impact, twelve developments would have no significant negative impacts with recommended terms and conditions. Two projects were exempt.

The committee changed the submission deadline from 30 days to 45 days as of the January, 2010 meeting. The timelines for projects submitted between up to this change were as follows: the majority of submissions required less than 60 days to complete, 4 projects required more than 60 days to complete and 6 projects required a resolution by the EISC to waive the standard submission deadline requirement. None of the project submissions were deemed to have the potential for significant negative impact. Please refer to the end of this report to view a summary table of this year's screening decisions (Appendix C).

In addition to developments that are screened, the EISC asks to be informed of other projects that are proposed for the Inuvialuit Settlement Region, but for various reasons are exempt from the screening process. This task is undertaken so that the EISC may have a broad picture of the activities being carried out within the ISR for the purposes of cumulative impact assessment. The EISC greatly appreciated the efforts of the other comanagement groups, the government agencies, the Aurora Research Institute and the Inuvialuit Land Administration during the reporting year to keep the EISC apprised of such activities.

The exempted projects in 2009/2010 were research projects that were non-government sponsored or funded research, or developments occurring on Inuvialuit Private Lands.
