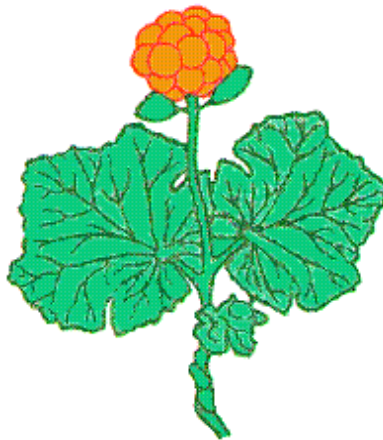

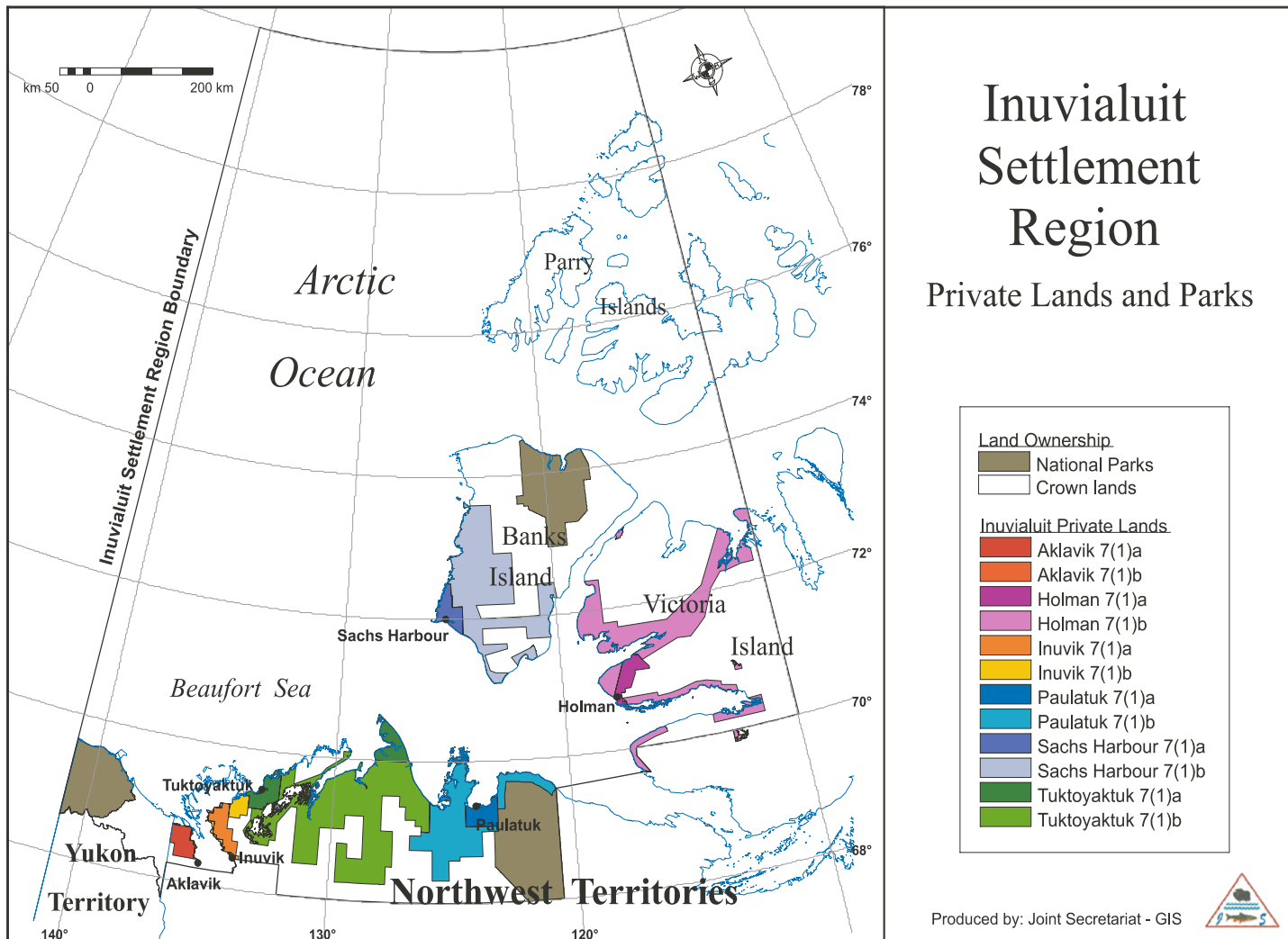


Figure 1. Private Inuvialuit Lands, Crown Lands and National Parks within the Inuvialuit Settlement Region.

To the members of the Screening Committee - both past and present - I give my respect and thanks. Their dedication and selfless attention deserves much wider recognition than is normally given. They have served the interests of the region, and Canada, in an exemplary way and have my continuing gratitude for their broad perspective, tolerance, and support. I take particular pride in the fact that during the past eight years each and every decision of the Screening Committee was reached by clear consensus.

## PERIOD OF THIS REPORT

The Environmental Impact Screening Committee (EISC) issues this report to describe its activities for the fiscal period of 1 April 1999 to 31 March 2000. The EISC has produced eleven annual activity reports since its inception in 1986.

## THE INUVIALUIT FINAL AGREEMENT

On 5 June 1984, the Committee for Original Peoples Entitlement (representing the Inuvialuit) and the Federal Government of Canada signed the *Inuvialuit Final Agreement* (IFA) which was subsequently legislated under the *Western Arctic (Inuvialuit) Claims Settlement Act* [S.C. 32-33 Elizabeth II, C.24.]. Provisions of the IFA enable the Inuvialuit to participate and be meaningful partners in all decision-making processes dealing with the management of the environment and wildlife within the Inuvialuit Settlement Region (ISR). Section 1 of the IFA expresses the following principles:

- É *To preserve the Inuvialuit cultural identity and values within a changing northern society*
- É *To enable the Inuvialuit to be equal and meaningful participants in the northern and national economy and society*
- É *To protect and preserve arctic wildlife, environment and biological productivity*

As one of five co-management bodies established under the terms of the IFA, the EISC plays a vital role in achieving these stated goals through implementing the screening portion of the IFA environmental impact screening and review process.

## MANDATE OF THE ENVIRONMENTAL IMPACT SCREENING COMMITTEE

The *Western Arctic (Inuvialuit) Claims Settlement Act* and the IFA take precedence over any other federal, territorial, provincial, or municipal law to the extent of any inconsistency or conflict between them. Developers, operators, and regulatory agencies are compelled by this Act to comply with the provisions of the IFA environmental impact screening and review process.

The IFA requires the screening of developments and activities of consequence to the ISR that could have a significant negative impact on the environment or wildlife harvesting. The IFA also dictates



that regulatory agencies must not issue licenses or approvals that permit any development to proceed without environmental screening and, if necessary, review.

Section 11 of the IFA provided for the establishment of the EISC to carry out the screening of relevant developments. Provisions governing the activities and operation of the EISC are described mainly within Section 11 and 13. Section 11.(13) requires the EISC to make one of the following decisions after examining a project description:

- a) that the development will have no significant negative impact and may proceed without environmental impact assessment and review,
- b) that the development could have significant negative impact and is subject to assessment and review, or
- c) that the development proposal has deficiencies of a nature that warrant termination of its consideration and submission of another project description.

Subject to the aforementioned provisions and the EISC by-laws, the EISC produced its *Operating Guidelines and Procedures* which governs its routine activities in regard to the actual screening of development proposals.

## **MEMBERSHIP**

The EISC consists of seven members, including the Chair. The Inuvialuit Game Council appoints three members. The Government of Canada (Canada), the Yukon Territorial Government (YTG), and the Government of the Northwest Territories (GNWT) designate one member each, who are then appointed by the Government of Canada. The Chair is appointed by the Government of Canada with the consent of the Inuvialuit Game Council. Each member is appointed for a three-year term with the option of re-appointment if agreed to by the nominating and appointing bodies.



Even though the Members are appointed by particular groups, the EISC serves as a non-partisan organization. The Members are expected to contribute as experienced individuals and not as representatives of their appointing body.

## ADMINISTRATIVE AND TECHNICAL ASSISTANCE

The EISC receives administrative, technical, and clerical support from the Joint Secretariat - Inuvialuit Renewable Resource Committees (Joint Secretariat) situated in Inuvik, N.W.T. Full-time assistance is provided by the Resource Person - Environment who serves as the Secretary to the EISC. Ms. Linda Graf has held this position since 1 November 1995.

During the period of this report, the EISC also received administrative support from various employees of the Joint Secretariat including: Dr. Norm Snow, Executive Director; Peggy Madore, Senior Administrative Officer; Angela Hunter, Finance Officer; Bridgitte Wolki, Secretary/Receptionist; Myrna Button, Office Clerk/Librarian; Suzanne Robinson, Administrative Assistant (until 4 Feb. 2000); Lucy Kudlak, Administrative Assistant (7 Feb.- 13 Mar. 2000); and Michael Muller, GIS Operator.

Mr. Ron Veale, of Veale, Kilpatrick, Austring, Fendrick and Fairman Barristers and Solicitors, Whitehorse, Yukon, provided contractual legal services until January 2000 when he was appointed to the Supreme Court of the Yukon Territory.

## ACTIVITIES

Members attended screening meetings approximately every six weeks and participated in other activities on behalf of the EISC, as required, to fulfill the mandate of the EISC.

## SUBMISSIONS

It is the responsibility of the proponent to submit a project description to the EISC for environmental screening. Screening decisions are made by a panel of five individuals consisting of the Chair, two Inuvialuit members, the Canada member, and the territorial member nominated by the territory (Yukon or N.W.T.) for which the project has been proposed. The Chair votes in the case of a tie.

Twenty-eight project descriptions were submitted to the EISC during 1999/2000 and three project descriptions were submitted at the end of the previous fiscal year, but were scheduled for examination during the present reporting period (Appendix A). Five project descriptions that were submitted in March 2000 will be considered during the next fiscal year. Altogether, the EISC screened 26 project descriptions during 1999/2000 including projects associated with research (15), hydrocarbon exploration (4), the clean-up of Distant Early Warning (DEW) sites (2), film production (2), mineral exploration (1), tourism (1), and an application for a land lease (1).

The EISC decided that the developments before it would have no significant negative impact, with one exception. A development submitted by Kuñnek Resource Development Corporation (to revitalize the reindeer industry in the Beaufort Delta) was considered to have the potential for significant negative impact. In November 2000, the EISC referred the development to the Environmental Impact Review Board for further environmental assessment and review. None of the project descriptions examined by the EISC were deemed deficient.

Community Consultation is a vital element of the screening process. Submissions are circulated to the relevant Hunters' and Trappers' Committee(s) for comment. The screening process for the majority of submissions (96%) required less than 60 days to complete. Fifty-eight percent of the submissions were screened within 30 days of receipt, with those received less than the required 30 days prior to the meeting being screened upon resolution to waive the standard requirement. One submission was deferred for several weeks to obtain further information from the proponent and comments from various co-management groups. One submission required 65 days to complete the screening process after being received too late to obtain the necessary community consultation prior to the next meeting.

In addition to developments that were screened, the EISC was informed of additional projects that were proposed for the ISR, but were exempt from the screening process. These included research projects that were exempt by virtue of having gone through the *IFA* co-management process and approval by the Inuvialuit Game Council, the relevant Hunters' and Trappers' Committee, the Wildlife Management Advisory Council (North Slope), the Wildlife Management Advisory Council (NWT), or the Fisheries Joint Management Committee.



## PRESENTATIONS AND GUESTS

- **Kuññek Resource Development Corporation, 20 April 1999**  
Mr. Lloyd Binder, General Manager, Kuññek Resource Development Corporation, provided the EISC with a brief presentation of his proposed Beaufort Delta reindeer herding activities.
- **Kuññek Development Resources Corporation, 5 October 1999**  
Mr. Lloyd Binder (as above) and Mr. Roger Connelly, Chief Operations Officer, Inuvialuit Regional Corporation, summarized Kuññek Resource Development Corporation's *Reindeer Herding Operations Plan*.
- **Explor Data Ltd., 16 December 1999**  
Mr. Philip Gregory, Vice-President, Explor Data Ltd.; Mr. Derek Melton, Senior Biologist/Project Manager, Golder Associates; and Mr. George Moskal, Advance Party Manager, Schlumberger, provided the EISC with a brief overview of their proposed winter seismic operation. Explor Data's plans included obtaining a 2D grid of high quality, regional data for the Mackenzie Delta using vibroseis technology. The data would then be made available to oil and gas companies.
- **Petro-Canada, 16 December 1999**  
Mr. John Kerkhoven, Supervisor Surface Land, Petro-Canada; Mr. Derek Melton (as above); and Mr. George Moskal (as above) described their proposed Mackenzie Delta *Seismic Program 2000*. Mr. Kerkhoven also informed the EISC that Petro-Canada had initiated quarterly talks with other oil and gas companies to share information about northern issues.
- **Environmental Impact Review Board, 16 December 1999**  
Mr. Robert Hornal, Chair of the Environmental Impact Review Board, reported on the 10 December 1999 signing of the *Memorandum of Understanding Between Environmental Impact Review Board and the Minister of Environment Concerning Approvals for Substitution of Process*. Mr. Hornal pointed out that the Review Board sought the agreement to avoid duplication, for example - a review under the *IFA* and one under the *Canadian Environmental Assessment Act*. Mr. Hornal summarized the issues that were debated during the five-year process culminating in signing of the document.
- **Darnley Bay Resources Limited, 15 March 2000**  
Mr. Phil Chidgzey, Project Manager, Darnley Bay Resources, discussed the Darnley Bay Exploration Program Phase III - drilling program. He confirmed that the company would only work in the Thrasher target area and would follow the proposed caribou survey protocol developed jointly by the Department of Resources, Wildlife and Economic Development and Bryant Environmental Consultants.



## OTHER ACTIVITIES

- **Report on the Draft Yukon Development Assessment Act, April 1999**  
The EISC reviewed the *Report on the Draft Yukon Development Assessment Act* prepared by the Yukon Council for the Economy and the Environment. The EISC noted the lack of consideration in the report for the 15-year record of screening under the *IFA*. The EISC responded by writing a letter to the Inuvialuit Regional Corporation and the Inuvialuit Game Council noting the environmental implications of the document.
- **Interim Management Guidelines for Tuktut Nogait National Park, August 1999**  
The EISC reviewed the *Interim Management Guidelines for Tuktut Nogait National Park* and provided comments to Parks Canada. In addition to acknowledging that the draft was a comprehensive, well written document, the EISC suggested that a statement be included which recognized the requirement for screening of activities that require permits or licences.
- **Ivvavik National Park Management Plan, August 1999**  
At the request of Parks Canada, the EISC examined the *Ivvavik National Park Management Plan*. As was the case with the previous Parks Canada document, the EISC noted that screening of development activities by the EISC is a requirement under the *IFA*. The EISC suggested that the document include reference to relevant sections of the *IFA*.
- **Inuvialuit Land Administration's draft Rules and Procedures, October 1999**  
As a courtesy, the Inuvialuit Land Administration provided the EISC with copies of their draft *Rules* and draft *Procedures*. The EISC suggested that it be made clear within the document that the Inuvialuit Land Administration reviews the findings of the Environmental Impact Screening and Review process only for those developments referred by the Inuvialuit Land Administration Commission to the EISC.
- **Updated Guide to the Inuvialuit Settlement Region for Mineral Prospectors and Developers, October 1999**  
On behalf of the EISC, the Secretary reviewed the updated *Guide to the Inuvialuit Settlement Region for Mineral Prospectors and Developers* prepared by Ms. Jessie Sloan of Alvarez, Sloan & Associates and relayed comments to Ms. Nellie Cournoyea, Chair, Inuvialuit Regional Corporation, and Mr. Lorne Matthews, Department of Indian Affairs and Northern Development. The EISC also examined the document, focussing their attention on those sections of the documents related to the *IFA* screening process.



- **Harmonization of Regional Environmental Assessment Processes, October 1999**

Following receipt of a letter from Mr. Robert Hornal, Chair of the Environmental Impact Review Board, the EISC began discussions concerning the environmental assessment process that would be followed in the event of a trans-boundary project. The EISC decided that the matter should be discussed further with the Environmental Impact Review Board and legal counsel of the Inuvialuit Regional Corporation. Discussions continue.

- **Mineral Agreement, November 1999 - Inuvialuit Regional Corporation and Department of Indian Affairs and Northern Development**

For the third consecutive year, the EISC did not conduct their “annual” review of mineral activities in the ISR. The Director of Mineral Resources, Department of Indian Affairs and Northern Development and the Inuvialuit Regional Corporation are endeavouring to resolve outstanding issues relating to the Agreement.

- **Access to Information from the Inuvialuit Harvest Study, January 2000 - ongoing**

The EISC discussed whether it could carry out its tasks with due diligence when it is unable to place data from the Inuvialuit Harvest Study on the public record. The EISC decided that access to the data should be raised with the Inuvialuit Game Council and the Inuvialuit Harvest Study Management Committee. The matter was still under discussion by the Inuvialuit Game Council at year-end.
