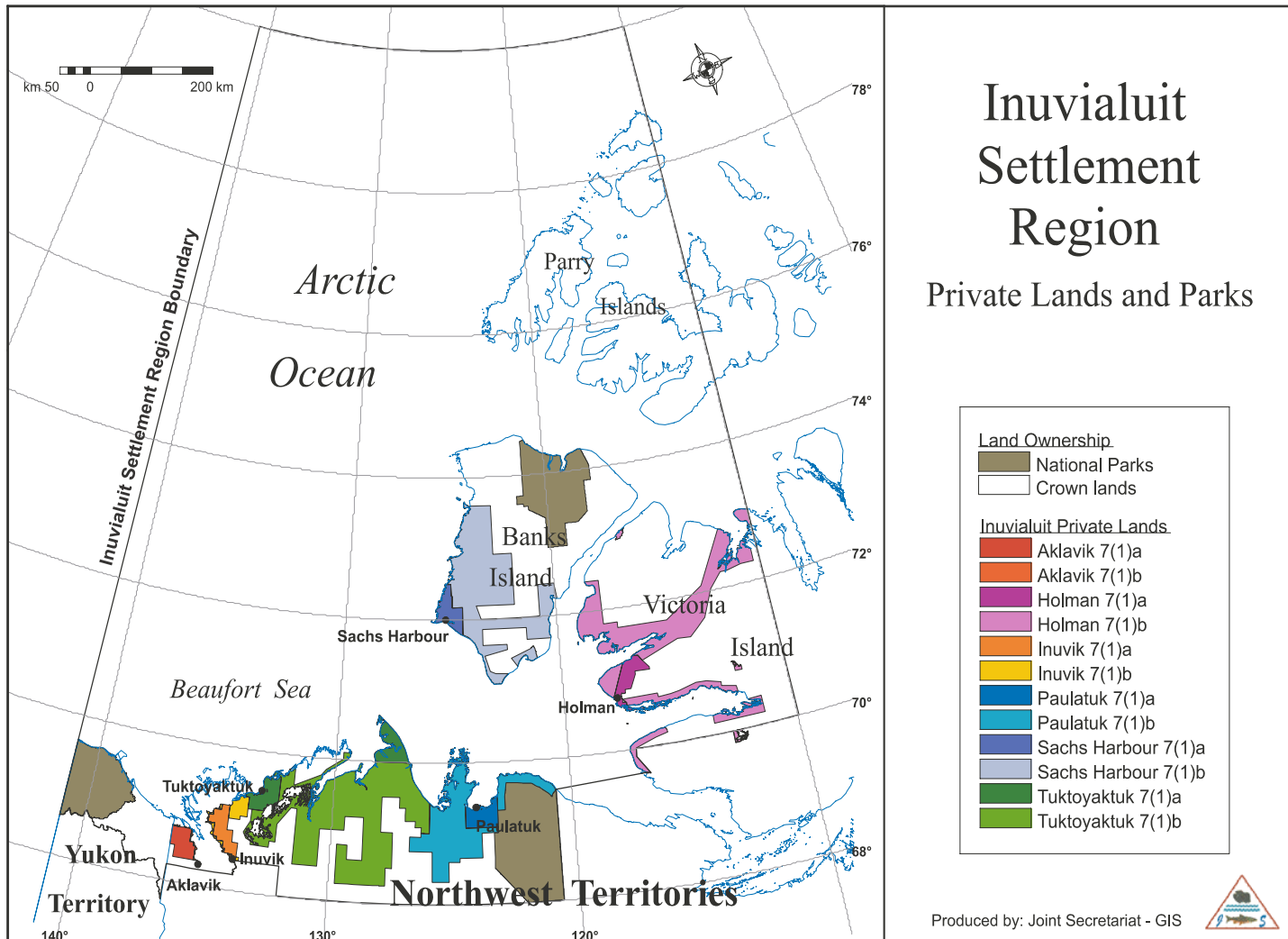


Figure 1. Private Inuvialuit Lands, Crown Lands and National Parks within the Inuvialuit Settlement Region.

Message from the Chair

The reporting period for this annual report has witnessed a number of changes. First there has been a change in the Chair of the EISC. After six and one half successful years at the helm of the EISC, Bill Klassen resigned to pursue other interests. During Bill's tenure as Chair significant changes took place in the ISR and to the environment screening and assessment provisions of the IFA. Another oil and gas boom took place in the early part of the 21st century, followed by the referral of the Mackenzie Gas Project to a Joint Panel review. In 2004 the Inuvialuit Final Agreement was amended increasing the responsibilities of the EISC to include the ability to recommend terms and conditions to mitigate any significant negative impact of the development project. This amendment necessitated a major revision to the EISC Operating Guidelines and Procedures. Under Bill's leadership the EISC screened the first offshore well that the region has seen for many years and in so doing raised the standard for such projects. Finally Bill helped negotiate a Memorandum of Understanding between the EISC/EIRB and the Mackenzie Valley Environmental Impact Review Board. In addition to this list of accomplishments Bill was able to maintain the high level of competency and efficiency of the EISC throughout his tenure.

The second change was the reappointment of Bill in July after a lapse of a month or so and Bill's resignation in February. In both instances the Committee was without a Chair for their meetings in July and February respectively.

The third change was the appointments of Fred McFarland as Chair of the EISC and Morris George by the Minister of Indian Affairs and Northern Development. Fred was appointed in March 2007 and Morris in November 2006. Morris' appointment was made on the recommendation of the Yukon Government. With these two appointments the Committee was at full strength at the end of the fiscal year.

The fourth change was the resignation of Christine Inglangasuk, the EISC Coordinator, in August and the hiring of Agnes Noksana in November as her replacement. During the intervening period, Larry Peckford, EIRB Coordinator and Katherine Thiesenhausen, WMAC (NWT) Resource Biologist handled the responsibilities of the Coordinator.

The workload in 2006/2007 was similar to that reported in the last report. Sixty project descriptions were submitted of which 57 were screened. There was a mix of development projects screened, oil and gas exploration, preparation work for the Mackenzie Gas Project, mining exploration, outfitting activities and a number

of government funded research projects. As noted in the last report, work continued on the revisions of the Operating Guidelines and Procedures with more discussions with the regulators and a request for comments or suggestions on the 2004 version of the Guidelines. While there were high expectations that the International Polar Year would create additional workload for the Committee during this reporting period, it did not materialize. Members of the Committee took part in a board orientation session as well as attending a training session on the Canadian Environmental Assessment Act and one on administrative law.

Although my time as Chair of the EISC in this reporting period has been brief, I would like to extend my appreciation to Bill for his assistance during the change over, the staff of the Joint Secretariat, namely Norm Snow, Connie Gordon, Erica Lugt, Meeka Kisoun, Bernice Joe and Peggy Madore for all their assistance in orienting me to the administration requirements of the EISC. I would also like to thank the Committee Members who were open and warm to my appointment. Finally I would like to acknowledge the hard work and dedication of the Committee Members over the past year during which all the above noted changes and disruptions took place. Throughout it all, they continued to fulfill their responsibilities in a competent and efficient manner.

Period of this Report

The Environmental Impact Screening Committee (EISC) has produced eighteen annual activity reports since its inception in 1986. This report describes the EISC's activities for the fiscal period of 1 April 2006 to 31 March 2007 – its twentieth year of operation.

The Inuvialuit Final Agreement

On 5 June 1984, the Committee for Original Peoples' Entitlement (representing the Inuvialuit) and the Federal Government of Canada signed the Inuvialuit Final Agreement (IFA), which was subsequently legislated under the Western Arctic (Inuvialuit) Claims Settlement Act [S.C. 32-33 Elizabeth II C.24.]. Provisions of the IFA enable the Inuvialuit to participate and be meaningful partners in all decision-making processes dealing with the management of the environment and wildlife within the Inuvialuit Settlement Region (ISR). Section 1 of the IFA expresses the following principles.

- To preserve the Inuvialuit cultural identity and values within a changing northern society
- To enable the Inuvialuit to be equal and meaningful participants in the northern and national economy and society
- To protect and preserve arctic wildlife, environment and biological productivity

As one of five co-management groups established under the terms of the IFA, the EISC plays a vital role in achieving these stated goals through implementing the screening portion of the IFA Environmental Impact Screening and Review Process.

Mandate of the Environmental Impact Screening Committee

The Western Arctic (Inuvialuit) Claims Settlement Act and the IFA take precedence over any other federal, territorial, provincial, or municipal law to the extent of any inconsistency or conflict between them. Developers, operators, and regulatory agencies are compelled by this act to comply with the provisions of the IFA Environmental Impact Screening and Review Process.

The IFA requires the screening of developments and activities of consequence to the ISR that could have a significant negative impact on the environment or wildlife harvesting. The IFA also dictates that regulatory agencies must not issue licenses or approvals that permit any development to proceed without environmental screening and, if necessary, review.

Section 11 of the IFA provided for the establishment of the EISC to carry out the screening of relevant developments. Provisions governing the activities and operation of the EISC are described mainly within Section 11 and 13. Section 11.(17) requires the EISC to make one of the following decisions after examining a project description.

- a) that the development will have no significant negative impact and may proceed without environmental impact assessment and review;
- b) that the development, if authorized subject to terms and conditions recommended by the Screening Committee, will have no such significant negative impact and may proceed without environmental impact assessment and review;
- c) that the development could have significant negative impact and is subject to assessment and review, or
- d) that the development proposal has deficiencies of a nature that warrant termination of its consideration and submission of another project description.

Subject to the aforementioned provisions, the EISC produced its Operating Guidelines and Procedures, which governs its routine activities in regard to the actual screening of development proposals.

Membership

The EISC consists of seven members, including the Chair. The Inuvialuit Game Council (IGC) appoints three members. The Government of Canada (Canada), the Yukon Territorial Government (YTG), and the Government of the Northwest Territories (GNWT) nominate one member each, who are then appointed by the Government of Canada. The Government of Canada with the consent of the IGC appoints the Chair. Each member is appointed for a three-year term with the option of re-appointment if agreed to by the nominating and appointing bodies.

Even though particular groups appoint the members, the EISC serves as a non-partisan organization. The members are expected to contribute as experienced individuals and not as representatives of their appointing body. Morris George was appointed as the Yukon representative in September. In January, after 6 years as chair, William Klassen, retired. Fred McFarland was appointed as chair in March.

Administrative and Technical Assistance

The EISC receives administrative, technical, and clerical support from the Joint Secretariat – Inuvialuit Renewable Resource Committees situated in Inuvik, NT. The EISC Environmental Assessment Coordinator who serves as the Secretary to the EISC provides full-time assistance. Christine Inglangasuk resigned from her position in August 2006. At that time the Review Board Resource Person, Larry Peckford assisted the EISC until November 2006 when the committee was able to hire Agnes Noksana.

Members attended screening meetings approximately every five weeks and participated in other activities on behalf of the EISC, as required, to fulfill the mandate of the EISC.

Submissions

It is the responsibility of the proponent to submit a project description to the EISC for environmental screening. Screening decisions are made by a panel of five EISC members. The Panel consists of the Chair, two Inuvialuit members, the Canada member, and the Territorial member nominated by the territory (YT or NT) within which the project is to occur. Decisions are made on a majority vote basis, with the Chair voting in the case of a tie.

In regard to submissions received by the EISC, 2006/2007 was a relatively busy year when compared with the previous few years. 65 descriptions were submitted.

Of the total submissions, 3 project descriptions were withdrawn by the proponent prior to the completion of the screening process:

Devon Canada Corporation [06/06-08]
Environment and Natural Resources (#173 Hay River Dene Reserve) [05/06-01]

No projects were referred to the Environmental Impact Review Board.

In summary, the EISC screened 65 project descriptions during 2006/2007 including: Hydrocarbon exploration projects (22); Mining exploration projects

(2); Government research projects (18); University research projects (11); Tourism projects (4); Community development projects (1); Filming project (3); US Government (1); and NGO (1).

During 2006/2007 the EISC decided that:

Eight of the proposed developments would have no significant negative impact, 46 developments would have no significant negative impacts with recommended terms and conditions. Eight developments were deficient and returned to the proponent. Three projects were withdrawn by the proponent.

The screening process for the majority of submissions (n = 45, 69%) required less than 60 days to complete, eleven percent (n = 11, 17%) of the submissions were screened in less than 30 days from the date of receipt, requiring a resolution by the EISC to waive the standard requirement. None of the project submissions were deemed to have the potential for significant negative impact. Please refer to the end of this report to view a summary table of this year's screening decisions (Appendix A).

In addition to developments that are screened, the EISC asks to be informed of other projects that are proposed for the Inuvialuit Settlement Region, but for various reasons are exempt from the screening process. This task is undertaken so that the EISC may have a broad picture of the activities being carried out within the ISR for the purposes of cumulative impact assessment. The EISC greatly appreciated the efforts of the other co-management groups, the government agencies, the Aurora Research Institute and the Inuvialuit Land Administration during the reporting year to keep the EISC apprised of such activities.

The majority of exempted projects in 2006/2007 were research projects that had gone through the IFA co-management process, were non-government sponsored or funded research, or developments occurring on Inuvialuit Private Lands.

The EISC routinely accepts presentations from proponents with project descriptions before the EISC, particularly when the proposal is controversial or complex.
